#### I. Call to Order

WHEREAS, each year the Tompkins Consolidated Area Transit, Inc. (TCAT, Inc.) Board adopts an annual Capital Expenditure Plan, and

WHEREAS, TCAT, Inc. (TCAT) attempts to maximize the use of all federal and state funds available for necessary capital equipment purchases and projects, and

WHEREAS, after reviewing current capital needs and considering all federal and state funding available for 2015, a Capital Expenditure Plan of \$330,470 with Tompkins County, City of Ithaca and Cornell University each making contractual payments of \$110,090 for the 2015 fiscal year ending December 31, 2015 has been prepared and reviewed,

THEREFORE, BE IT RESOLVED, the TCAT Inc Board adopts a Capital Expenditure Plan for fiscal year ending December 31, 2015, totaling \$330,470.

# VII. Committee Reports

#### • Executive Committee

K. Whang reported that the Executive Committee met on December 4<sup>th</sup>, 2014 and discussed TCAT UAW negotiations, Green Street, fuel cell hydrogen bus update, TCAT system safety plan, and the vanpool agreement.

# Budget Committee

B. Gray reported that the Budget Committee met on November 18<sup>th</sup> 2014 and discussed Revenue Expenditure Report October 31, 2014, Fuel Report, preliminary 2015 health insurance rates, 2015 Operating budget, 2015 Capital budgets and federal grants status.

#### • Transit Service Committee

M. Yarrow reported that the Transit Services Committee met on November 6, 2014 and discussed updates on Passenger Miles traveled 2014 and Qualitative Rider Survey, service standards plan and public input sessions an overview of service adjustments for January 2014; proposal for expansion of "emergency ride home" program to TCAT monthly pass subscribers and vanpool participants; and updates on various staff projects.

#### Human Resources Committee

S. Murtagh reported that the Human Resources Committee met on November 13<sup>th</sup>, 2014 and discussed current headcount, hires, separations, retention rate and labor issues.

### • Planning Committee

The Planning Committee did not meet.

B. Gray asked before we go on to the Executive Session can we back up to the action items. We adopted the resolution for the capital plan Resolution 2014 – 21 and in it we refer to a capital expenditure plan that is listed here as \$330,470, that is actually the money that is made up in the local contributions, the number should be \$1,065,803. He stated he would like to ask if we could modify the resolution to read the actual total expenditure.

K. Whang asked S. Brock how that works.

- S. Brock stated it would be a motion to reconsider and amend the number and vote again.
- B. Gray stated he would like to move that we reconsider the resolution 2014 21 Adopting the TCAT Inc. 2015 Capital Expenditure Plan, D. Howe seconded. The motion to reconsider Resolution 2014 21 was passed unanimously.
- B. Gray made a motion to move the Capital Expenditure Plan in the resolution as written with the exception to modify the last Whereas and the final Resolved that the Capital Expenditure Plan be listed as \$1,065,803. D. Howe seconded. The resolution as amended passed unanimously.
